### 3. Insurances

The Contractor shall be responsible to provide the following insurances for the project (in the joint names of the Contractor, Employer and the Customer) Within 14 days from the receipt of PO:

- I. Erection All Risk Insurance (Equivalent to PO value)
- II. Public Liability Insurance For a value of equivalent to PO value.
- III. Workmanship Insurance (As per UAE laws)
- IV. Plant and Equipment Insurance (for full replacement value)

The Scope of the works including twice per month wet cleaning for 7,671KWp rooftop solar system and preventive maintenance as following

- a) Preventative maintenance work as per below table schedule.
- b) Process the warranty claim of solar panels and inverters if required.
- c) Providing monthly preventive maintenance report on the fifth (5<sup>th</sup>) of every month including monthly checklists of solar panels cleaning and preventive maintenance Schedule as per the table and solar plant monthly generation from inverter screen or DEWA solar meter
- d) Submission of detail corrective report after rectification of issue.
- e) Corrective maintenance for damaged parts after getting cost approval from Etihad and client based on agreed submitted quotations.

7		Weather Stations system	Quarterly	Visual Inspection of weather stations and sensors

- 1. The contractor to provide a detailed scope of cleaning & maintenance activities related to the full scope.
- 2. All emergency maintenance calls are to be attended to immediately 24x7 round the clock 365 Days.
- 3. The contractor shall have maintenance experience with similar solar plants.
- 4. The maintenance & cleaning of the PV array shall be carried out in accordance with the manufacturer's Recommendation.
- 5. The price includes providing 24 PV cleaning visits yearly (Twice every month and quarterly maintenance visits to ensure to maximization of the performance of the solar GRID system.



- 6. The contractor shall be responsible for attending to all the breakdowns and four times quarterly preventive Maintenance with monthly planned PV cleaning and repair, and replacement of spare, which may wear out due to normal use.
- 7. The contractor shall be responsible to provide diagnostic testing for low-power production.
- 8. Inverter maintenance (Once in 3months)
- 9. String testing (open circuit test, short circuit test, insulation resistance test (Not Limited)) once in 3 months (Once in 3months)
- 10. Panel checking (thermal imaging (Not Limited)) (Once a year)
- 11. DC combiner box maintenance (Once in 3 months)
- 12. AC collection board maintenance (Once in 3 months)
- 13. Performance reporting (energy generation of inverters, any issues identified during the visit, etc.) –(Every Month)
- 14. The contractor shall clean the PV array from Dust, and bird drops. Use clean water and avoid
- 15. The contractor shall not to use harsh materials when cleaning solar panels as they could Couse damages.
- 16. The contractor shall take proper care as once they start cleaning of solar panel because of slippery roof.

  Always Use safety belt or a harness for support.
- 17. The contractor shall watch out for dirt on the solar panels to make sure it does not build up since they can absorb sunlight better when they are free of dirt.
- 18. Any penalty imposed by local authority shall be borne by the contractor.
- 19. Contractor to bring all necessary tools, materials and equipment has to finish the works. Such as mops, brush, water pump, pressure pumps, water tanks, scaffolding, ladders, lifting machines etc...
- 20. In case of delay in completion of maintenance works Etihad Esco reserves the right to levy the penalty of Dhs 625 /day.
- 21. Etihad Esco may terminate the Annual maintenance contract or at any time by giving the contractor 30 days prior written notice.
- 22. The recommended offer shall be conforming and in accordance with Etihad Esco energy management policy & EMS policy

### **General Conditions**



- 1. The contractor at DEWA work premises shall follow DEWA safety & environment policy, rules and regulations during the contract period.
- 2. The contractor shall carry out a risk assessment for all his works. This risk assessment shall be from Safety as well as Occupational Health considerations.
- 3. The contractor shall prepare the method of statement to be submitted for the Etihad Esco approvals.
- 4. Toolbox talks should be given to the workers by their supervisor, a copy of which shall be given to Etihad Esco.
- 5. No welding, flame heating or cutting, grinding, pneumatic chipping, etc. shall be carried out without specific clearance from Etihad Esco through "Hot Work Permits". The hot work permit if required shall be obtained on daily basis.
- 6. The contractor shall at no time keep inflammable substances in the plant/work areas.
- All hazardous wastes shall be moved under direction from and with written approval to special storage
  area.
- 8. The contractor's work will fall within the purview of safety surveys conducted regularly by the Etihad Esco safety section. All the workmen should wear necessary PPEs like uniform, safety shoes and helmet while at work.
- 9. All cranes, vehicles, special tools of contractor shall be inspected and tested by capable authorities and contractor shall provide Etihad Esco with copy of certificates of their fitness before their use at site.
- 10. The contractor shall produce all equipment like rigging tools, grinding machines, drilling machines, hand tools, precision tools with all valid test certificates from 3rd party licensed certifying agencies.
- 11. Erection & use of scaffolding, use of lifting trolleys shall be certified by Etihad Esco authorized personnel and shall be supervised by Contract supervisor before executing the job on site.
- 12. On a written application with relevant particulars of the staff and vehicles of the contractor, Etihad Esco will issue temporary Entry Passes for them valid up to the period of contract work. The contractor shall apply for the Entry Passes for entire duration of the contract 3 days in advance with a copy of passport with valid visa, 2 passport size photographs and identification card issued by the company for each staff, additionally with a copy of driving license for the drivers and a copy of valid Registration certificate for



the vehicles.

- 4. We understand that, award of Contract by Employer, does not imply that or warrant us to immediately start any of the services under the contract. Contractor also understand that he shall mobilize services under the awarded contract only upon receipt of subsequent explicit written notification from Employer accordingly. However, for all purposes, the Contract commencement shall be firmly considered as 1<sup>st</sup> March 2025 (i.e., the date from which actual services are mandatorily required to be started at the awarded premise(s)/location(s) as per Employer's tender requirements).
- 5. Your written acceptance on our contract awarding letter shall constitute a binding Contract between us.



- 6. We confirm that the terms and Conditions given in the RFP are acceptable to us and if our proposal is accepted, we shall execute a contract with Al Etihad Energy Services Co LLC accordingly without any exceptions, we further confirm to commence service within (......) days of the mobilization notice issued by the Employer.
- 7. In all cases the Contract shall be deemed to commence as from the date of officially awarding this Contract.
- 8. We understand that you are not bound to accept the lowest or any proposal you may receive.
- 9. We understand that Employer reserves right to award whole or part of work without any extra cost to Employer.
- 10. We understand that we will engage the labourers and staff sponsored by our company only. We shall obtain written confirmation & permission from Employer prior to utilizing any sub-contractors / other company personnel.
- 11. We understand that our quoted unit/annual price will be firm for **03 years** from the date of award of contract. We also understand that in case we are not agreeable, Employer reserves the right to encash the Performance Bond submitted by us.
- 12. We understand that Employer have the right to award complete job to one bidder or award selected sites/facilities to multiple bidders
- 13. We understand that in case of award of project to multiple bidders, its employers discretion to choose the sites/facilities to be awarded for bidders.
